# SECONDARY DATA RESEARCH

There is a center of Information Freedom (FOICA) and also governmental agency of Personal Data Protection that touch upon the issue of child's right to privacy violations.

There's a guideline on child's privacy protection for families, educational centers and media outlets, however, it's in a form of an advisory.

There're several laws and rights in Armenia regarding personal data protection and the overall rights of the child to well-being, however, **there's no specific law about the privacy right of the child in the media sphere.**

# **MEDIA MONITORING: AVETISYAN FAMILY CASE**

- **January 12, 2015 six people found dead in their house in Gyumri, Armenia.**
- **Two children among the victims.**
- **Large media reaction and coverage on the case.**
- **Personal information and images of the child victims spread on the web.**

# MEDIA MONITORING RESULTS

- Only 2 media outlets(panarmenian.am, civilnet.am) from the list ( See slide 5) didn't publish the pictures of children.
- All the other media outlets on the list have shown names of the victims, their place of residency and their pictures, which certainly portray their physical appearance.
- Less credible media outlets published the same news (including personal information and pictures of the child victims) several times.
- Some of the popular media outlets also published the pictures of the victims several times (168.am).

# ONLINE SURVEY RESULTS OVERVIEW

- Most of the respondents think that media has no right to expose the personal information of the child (91,5 %).
- Half of the respondents indicated that they've seen such publications (51,4 %).
- Several respondents indicated that if the publication is made for the sake of child's well-being, then the information and pictures can be published.

# INTERVIEWS

The overall message from the interviews is that the reason for the violation of child's right to privacy is the unprofessional approach of journalists.

The fact that people believe every news they see without checking the source is another reason for this tendency.

And also the fact that parents publicize their children is a massive factor in the emergence of the issue.

However, the experts mentioned that the issue is much bigger than the primary violation of the children's rights.

# CONCLUSION

1. The presence of “lazy journalism” among media outlets
2. Lack of media literacy among the Armenian population
3. Absence of specific law protecting child’s right to privacy in the sphere of media
4. Irresponsible actions of parents


# FURTHER RESEARCH
